RESERVATION OF FOREST BLOCK - JAYASHANKAR BHUPALPALLY DISTRICT - RESERVATION OF KOTHAPALLY COMPENSATORY AFFORESTATION FOREST BLOCK TO AN EXTENT OF AC.26.18 GTS. (OR) 10.704 Ha. IN SY.NO.1196/1/2 OF KOTHAPALLY VILLAGE, BHUPALPALLY MANDAL & DIVISION, JAYASHANKAR BHUPALPALLY DISTRICT, KALESHWARAM CIRCLE UNDER SECTION 4 OF THE TELANGANA FOREST ACT, 1967 (ACT NO.1 OF 1967) READ WITH SECTION 4 OF THE INDIAN FOREST ACT, 1927 (CENTRAL ACT NO.16 OF 1927).

In exercise of the powers conferred by section 4 of the Telangana Forest Act, 1967 (Act No.1 of 1967) read with Section 4 of the Indian Forest Act, 1927 (Act No.16 of 1927), the Government of Telangana hereby declared to constitute the land (transferred to Forest Department in lieu of Diversion of Forest land of 10.704 ha. in Tadicherla Reserve Forest of Bhupalpally Division in favour of TSGENCO for constructions of belt conveyor corridor for transportation of coal from Project Tadicherla-1 Coal Block to KTPP Project) within the boundaries specified in the schedule below as a Reserve Forest under the said Act, and appoints the Forest Settlement Officer, Bhupalpally in this regard to said land to consider objections, if any, and to enquire into and determine the existence, nature and extent of any rights claimed by or alleged to exist in favour of any person in or over any land comprised within such limits, or to any forest produce of such land and to deal with the same as provided in Chapter-II of the said Act held by the said Forest Settlement Officer:

**NORTH (A - B):** The boundary line of the proposed Forest Block starts at Station No. 1 as permanent boundary pillar marked with Geo Coordinates Lat: 18.350124, Long: 79.774689 i.e., shown as point 'A', which is located at the North-Side of the proposed block and the boundary line runs towards slightly South-Eastern direction upto Station No. 4 and then the line runs towards South direction upto Station No. 5 and then the line runs towards slightly South Eastern direction upto Station No. 7 and then runs south direction upto Station No.8 from station No.8 the line turns towards Eastern direction and runs upto station 11 i.e. shown as Point 'B', which is located at the North-East corner as shown in the map of the proposed Forest Block with the following Geo-coordinates in WGS-84 datum of each station and distances from the Station to Station. From the Station No. 1, when the boundary line of the proposed Forest Block proceeds to the Station No. 11 through the Station No. 2,3,4,5,6,7,8,9,10, and 11 the right hand side area is the proposed "**Kothapally**" Forest Block of Sy. **ANNEXURE -I****Proposed Forest Block Kothapally (C.A.Area)**

Internal angles at each Station with Stations on either sides and distances between stations. The distance from previous station is recorded against the station number in table. The internal angles shall be established using the internal/external angle measuring instrument only like theodolite, but not with magnetic compass; after establishing at least two consecutive points with Differential Global Positioning System or Global Navigation Satellite System (DGPS)/ DGNSS) at 2 km interval along the boundary.
